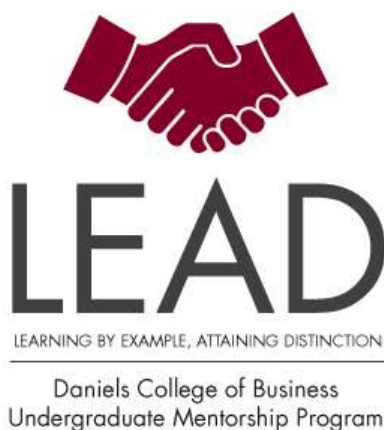

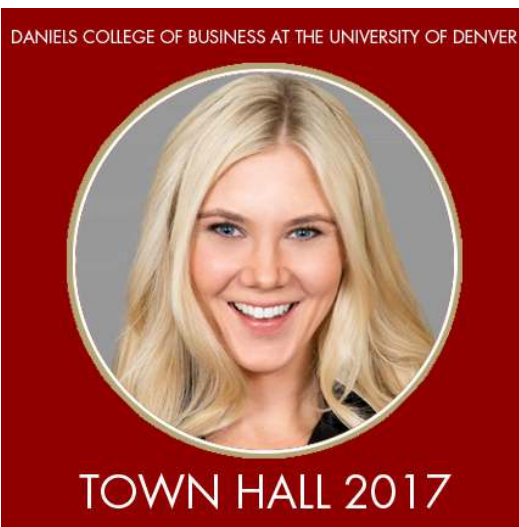
Apply today for the School of Accountancy's LEAD Mentor Program
