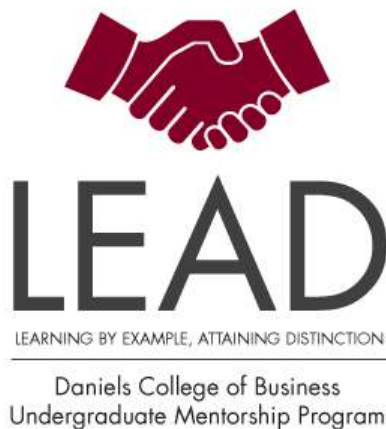

## Scholarships

- **AICPA/Accountemps Student Scholarship:** The AICPA/Accountemps Student Scholarship Award, provides financial assistance to outstanding accounting students who demonstrate potential to become leaders in the CPA profession. Eligible applicants must be pursuing an undergraduate or graduate degree in an accounting program, planning to pursue CPA licensure, be enrolled during the 2018-19 academic year, have a 3.0 GPA or above, demonstrate financial need, and be an AICPA Student Affiliate member (apply online at no cost here: [www.thiswaytocpa.com/aicpa-student-membership](http://www.thiswaytocpa.com/aicpa-student-membership)). **The application deadline is March 1, 2018, 1pm.** To apply visit the [AICPA/Accountemps Legacy Scholarship webpage](#).
- **Frank L. Greathouse Government Accounting Scholarship:** The Frank L. Greathouse Government Accounting Scholarship provides scholarships to students preparing for a career in state and local government finance in the United States or Canada. This scholarship is open to undergraduate and graduate students studying/majoring in accounting and have a letter of recommendation from someone who can speak to your commitment to the public sector. **The application deadline is January 26, 2018.** To apply - and to view other scholarship available for those interested in the public sector - visit the [Government Finance Officers Association website](#).
- **IMA Scholarship Program:** IMA offers scholarships to graduate and undergraduate students based on specific criteria. Applicants must be enrolled a minimum of six credit hours when applying and be planning on registering for a minimum of six credit hours in the next academic year. Students can be either full-time or part-time but must have a minimum cumulative 3.0 GPA, be enrolled in accounting, finance, or information technology, and sit for at least one part of the CMA exam before the completion of the fall term. - **ISACA Scholarship Program:** The Information Systems Audit and Control Association (ISACA) Scholarship Program connects exceptional people with exceptional knowledge to provide student members a wide range of member values and benefits. Full-time or part-time undergrad and graduate students studying Information systems, business, accounting, or computer science at an accredited college in Colorado are encouraged to apply. **The application deadline is March 16, 2018.** To begin your application, visit [ISACA's Denver Scholarship website](#).
- **Ritchie-Jennings Memorial Scholarship:** The Ritchie-Jennings Memorial Scholarship is currently accepting applications from accounting, business administration, finance, and criminal justice majors who have a desire to pursue a career in fraud examination or similar anti-fraud profession. Applicants need to be currently enrolled as a full-time student and plan on being a full-time student in the 2018-2019 academic year. 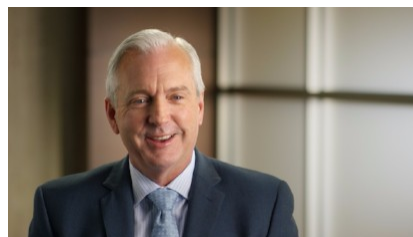
