

Meet Alumna Ann Marie Milinazzo (BSAcc, MAcc 1987)

Why did you decide to receive your degree from the School of Accountancy? Were there any particular experiences that triggered your interest in accounting or an influence in your life that led you this way?

I was a recipient of the Boettcher Scholarship. Because of the Boettcher Foundation's extraordinary commitment to Colorado, the scholarship winner had to attend a college in Colorado. I chose DU because of the outstanding reputation of the University and especially the School of Accountancy. At that time it was one of only a few universities that offered the five-year program to get a master's in accounting degree. It was the only school where I applied, so needless to say, I had a strong conviction to the University.

I became very interested in accounting in high school when I took my first accounting classes. This was back in 1980 when accounting software for small businesses was just becoming available. What did you enjoy most about getting your degree from the School of Accountancy? Any highlights of your college career you'd like to share?




