## "Add insult to injury"

### Meaning:

To make a bad situation worse

### Origin

"Add insult to injury" comes from a fable written by Phaedrus in the first century AD. The story goes like this: one day a fly came



in through the window and bit a bald man on the head. In trying to swat the fly, the man ended up hitting himself in the head. The fly then said, "You want to avenge an insect's sting with death? What will you do to yourself since you have added insult to injury?" In other words, the bald man was already injured from the fly's bite, but by trying to kill the fly for such a small injury (the "insult"), he ended up making his own situation worse by hurting his head. Today, this phrase is often used to indicate when a person has already been offended and the offender does something to make it even worse.

### Example:

Natalia: "First Franklin was an hour late to meet me for dinner, then to add insult to injury, he criticized what I ordered to eat. It was like prom all over again."

Wallace: "Sounds like he needs a dating lesson."
