**Additional Information:**

<sup>1</sup>Entering MSAQF students must meet three required prerequisite courses. Students can be admitted to the program before the prerequisites are met. In this case, students take the prerequisite courses as they complete the MSAQF program and a student's degree plan may range from 45-57 credit hours. The three prerequisite courses are:

- Introductory Financial Accounting (ACTG 4610)

- Quantitative Methods in Finance (FIN 4170)
- Managerial Finance (FIN 4630)

**Students may demonstrate competency in the three prerequisite courses in the following manner:**

Accepted to the MSAQF program through the University of Denver's Undergraduate Master's Accelerated Admissions Process (MAAP) and earned a B- or better in the undergrad equivalent course as part of their undergraduate degree program. Undergraduate degree must be in finance.
Passing an on-campus waiver exam before the start of the MSAQF program.

For detailed academic policy information, refer to Graduate Student Handbook. An overall GPA of 3.0 is required for graduation. Electives must be graduate (4000-level) courses.
